REMEMBERING & THANKING THE CORVETTE CHIEF ENGINEERS and the Design Engineers!

Harley Earl "The Father of the Corvette Design" was the Chief of Design Engineer for GM from 1953-1967. He was Hollywood born and the Designer who oversaw 29 years of GM production involving 50 million motor cars. He created the "tail fins"; and a low and longer vehicle.




Bill Mitchell was hired by Harley Earl in 1935. Mitchell was Head of Design from '58-'77. He created the "Bill Mitchell Fenders." Bill Mitchell – can you imagine arguing with Zora Duntov in 1960 over control of the shape of the Corvette?

Zora Arkus-Duntov was always celebrated at our NCRS National Conventions. Always willing

to talk to our members and sign autographs.

I have one!


Following are the five Chief Engineers.





Zora Duntov was Chief Engineer from 1967-1975. Zora joined the Corvette team in '53 and transformed Corvette from a stylish sportscar to a high-performance machine. Dave McClellan signed my air cleaner and in twenty-five years, we haven't erased his signature. Dave McLellan was Chief Engineer from 1975-1992. He put the Corvette on the road to recovery developing the C4 in 1984, reintroducing the convertible in 1986

and bringing out the ZR1 in 1990. Auto Enthusiast Magazine recognized him at #six in the Corvette legacy of ten men who mattered in this Century of Chevrolet. Dave wrote the book "Corvette from The Inside" enjoyed by Corvette enthusiasts even today.

Dave Hill was the 3rd Chief Engineer for the C5 and C6 generations. Earlier, Dave Hill was the Engineering Manager for Cadillac. Dave also reintroduced the Z06 option for the C5 and C6.

GM'S New and Retired Chief Engineers following in the foot-steps

of these extortionary visionaries has continued. Each has made extraordinary contributions and we all look forward to riding along and following their dreams. Tom Wallace (pictured left) stepped in when Dave Hill retired. Tom served from 2006-2008.

In Corvette history, only two engineers were real race car drivers, Zora and Tom Wallace. He raced Daytona, 12 hours of Sebring, and Talledega 6-hour races. Tom led a team to produce the fastest Corvette to date, a 2009 638HP, 200 MPH ZR1.

Tadge Juechter was Chief Engineer from 2008 to 2020. He was with GM for 47 Years.

Mr. Juechter worked on 5 generations of the Corvette.

He led development of the C7 and was in charge of the interior re-design. He created the C8 mid-engine Corvette from the ground up.

Josh Holder became Chief Engineer in 2020. Josh attended our 2024 National Convention in Hampton Road, Virginia. Mr. Holder brought his 2025 Corvette ZR1 Coupe.

1956-57 Courtesy Light Door Jamb Switch Joe LeMay in Joe's Garage

There are two items unique to a 1956-57 Corvette Courtesy Light Door Jamb Switch. They are the button color and the smooth surface that is visible. The button should be dark brown Bakelite. The unpolished stainless steel switch faceplate should be smooth with no stamped embossments. From the JM: These switches are smooth faced unpainted and normally use brown plastic contact buttons. The switch mounting flanges should be smooth and not contain any ridges.

Finding a replacement is a challenge to know what to look for. Buttons can be black or dark brown. The switch place face on replacements has three stamped embossed curved areas around the button. This is also the typical configuration for 1958-62 Corvettes. Both items are possible to correct and will require disassembling the switch.

A switch with the typical dark brown button will be possible to find. The door jamb switch with the typical switch plate is found on 1941-56 Chevy trucks PN 4598597, and on 1955-56 passenger cars. Carefully look at the switch plate face when purchasing on-line. Some of those listed with the correct PN with have embossments. The issue with a switch installed in steel vehicles is the body is used as the ground. The switch has only one wire terminal on the back. Corvettes will have two terminals. The second terminal goes to ground.

If you obtain switches for a steel body car, you will also need the switches that were in the Corvette. The four switches will need to be disassembled so that the section with the two terminals from a Corvette can be installed into the stainless-steel body with a smooth faceplate. It is easy to bend the four prongs on the back to disassemble the switch. Then reverse the process to assemble it.
